HEALTH GUARANTEE:

Your pup will come with a **Health Guarantee** included in the **Bill Of Sale**. Your pup will be up to date on vaccinations and up to date on worming. A Vet check is available for cost and is required for shipping. You must take your pup to a veterinarian within 5 days from the time that you or your agent receives the pup. If you are unable to take your pup to your regular veterinarian you must take your pup to any other licensed veterinarian. That includes weekends. You will be provided with the health record, which you will provide to the veterinarian. He will advise you when to come back for other vaccinations. If the veterinarian finds a health condition or defect that would make the pup unsuitable for a pet, the pup and a written statement from your veterinarian stating the problem must be returned to seller immediately. The seller will refund the purchase price of the puppy or exchange the dog for another dog of equal value (seller's choice). Should you not take your pup for its examination, you will assume full responsibility for its health. All expenses are the responsibility of the buyer. Seller assumes no responsibility for this puppy after leaving the premises; such as medical expenses, landlord disapproval, allergies to animals, disagreement of family or for any other reason, other than stated. The breeder is NOT responsible for any vet bills or any other bill regarding this pup nor is seller responsible for damages, physical or emotional to the buyer's self or possessions and likewise to other individuals. The breeder will not replace a puppy whose problem is a result of its new environment. Your breeder will always be a resource of information and be willing to offer advise to help in any reasonable way on the behalf of the welfare of this puppy. By placing a deposit or paying in full for this puppy, the purchaser has agreed to all of said guarantee.

- Registration and Ownership Transfer; Warranty of Ownership.** Upon payment in full of the Purchase Price to Seller, all right, title and interest in the Dog shall pass to Buyer. The Seller, at its own cost, will promptly take any other actions necessary to transfer legal ownership of the Dog to the Buyer. Buyer is responsible, at its cost, for obtaining AKC registration upon receipt from Seller of the Dog's pedigree and documentation required for AKC registration. The Seller represents and warrants to Buyer that Seller is the legal and true owner of the Dog and that it has the unqualified right to sell the Dog. The Seller further warrants that the Dog is sold free and clear of any liens, security interests, mortgages, or other encumbrances. Seller guarantees that the Dog is a purebred Bichon Frise and represents that the Dog's pedigree includes champions, evidenced by the pedigree documentation provided to Buyer. Buyer represents the Dog is being purchased as a companion pet, and not for resale or other purpose.
- Short-Term Good Health Warranty.** The Dog is guaranteed to be in good health upon delivery to shipper. The Dog has no medical conditions nor is the Dog on any medications. The Seller has advised that the Dog has a friendly disposition with no known behavioral issues, and is not known to harm others. Seller represents that the Dog is current on all vaccinations, and also represents that the Dog has been wormed. If the veterinarian finds a health condition or defect that would make the pup unsuitable for a pet, the pup and a written statement from your veterinarian stating the problem must be returned to seller immediately. The seller will refund the purchase price of the puppy or exchange the dog for another dog of equal value (seller's choice). Should you not take your pup for its examination, you will assume full responsibility for its health. The Seller will not be responsible for the cost of the examination or transportation cost.
